Chris joined Phillip Resources Management in 2008 to establish the Phillip Resources Fund. Chris is also the Chairman of ASX listed Dart Mining NL.

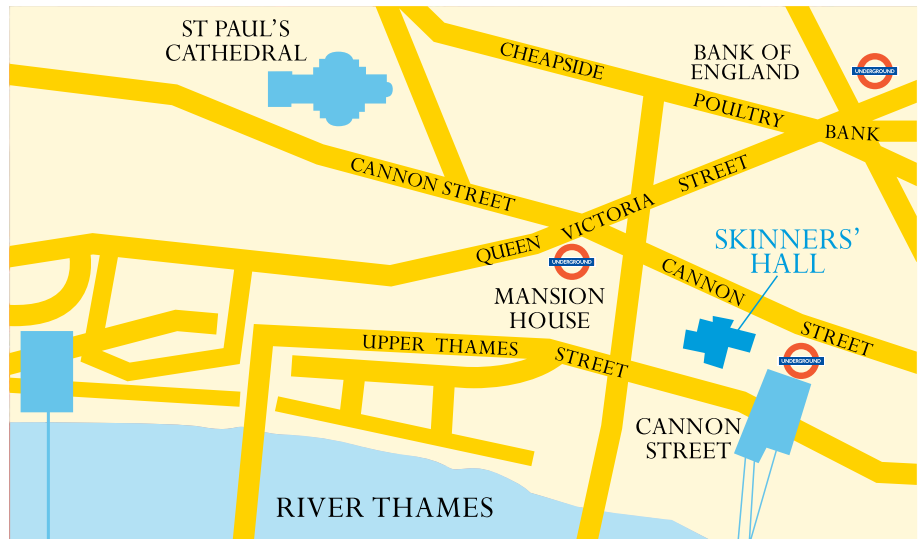
